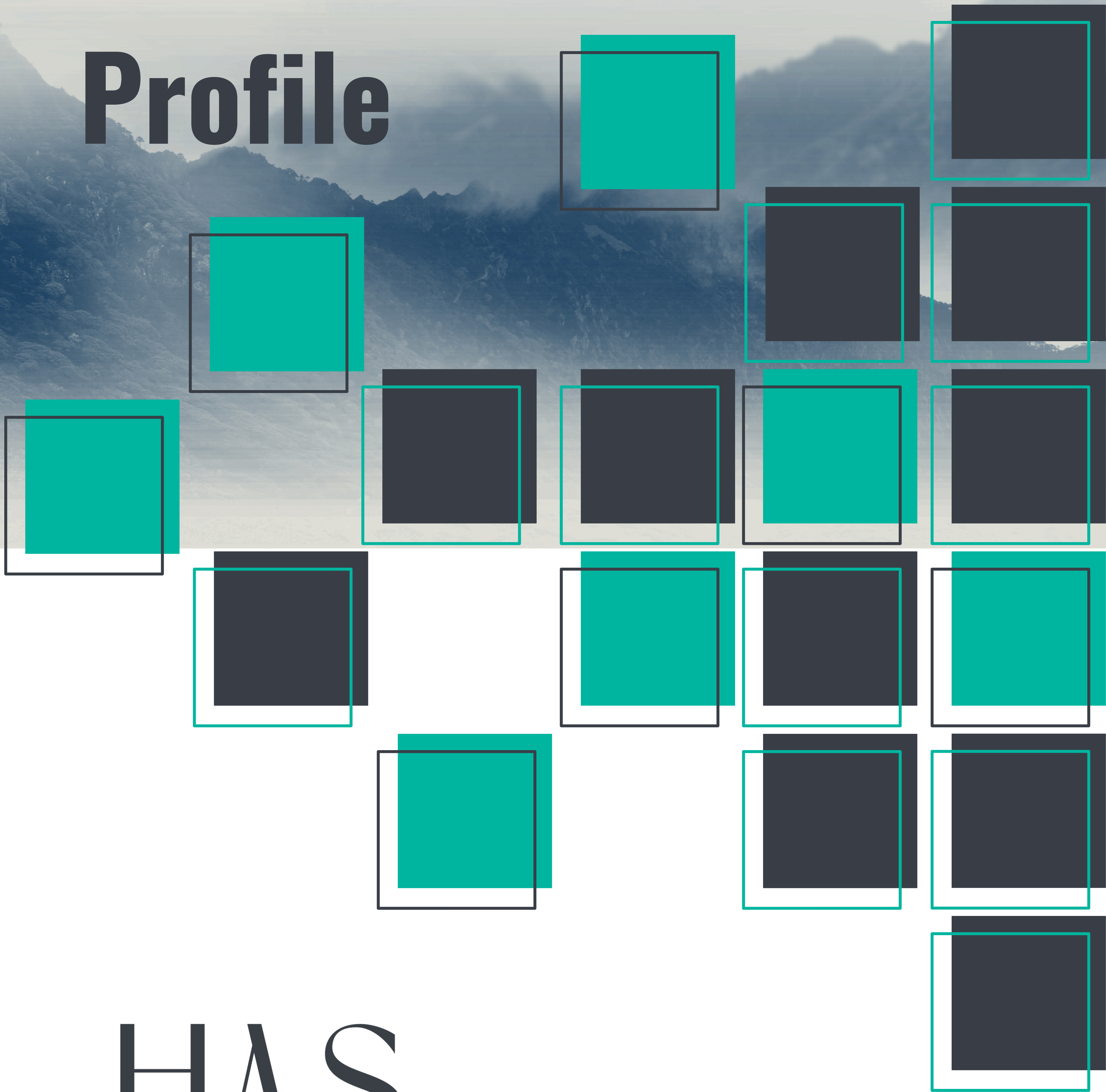


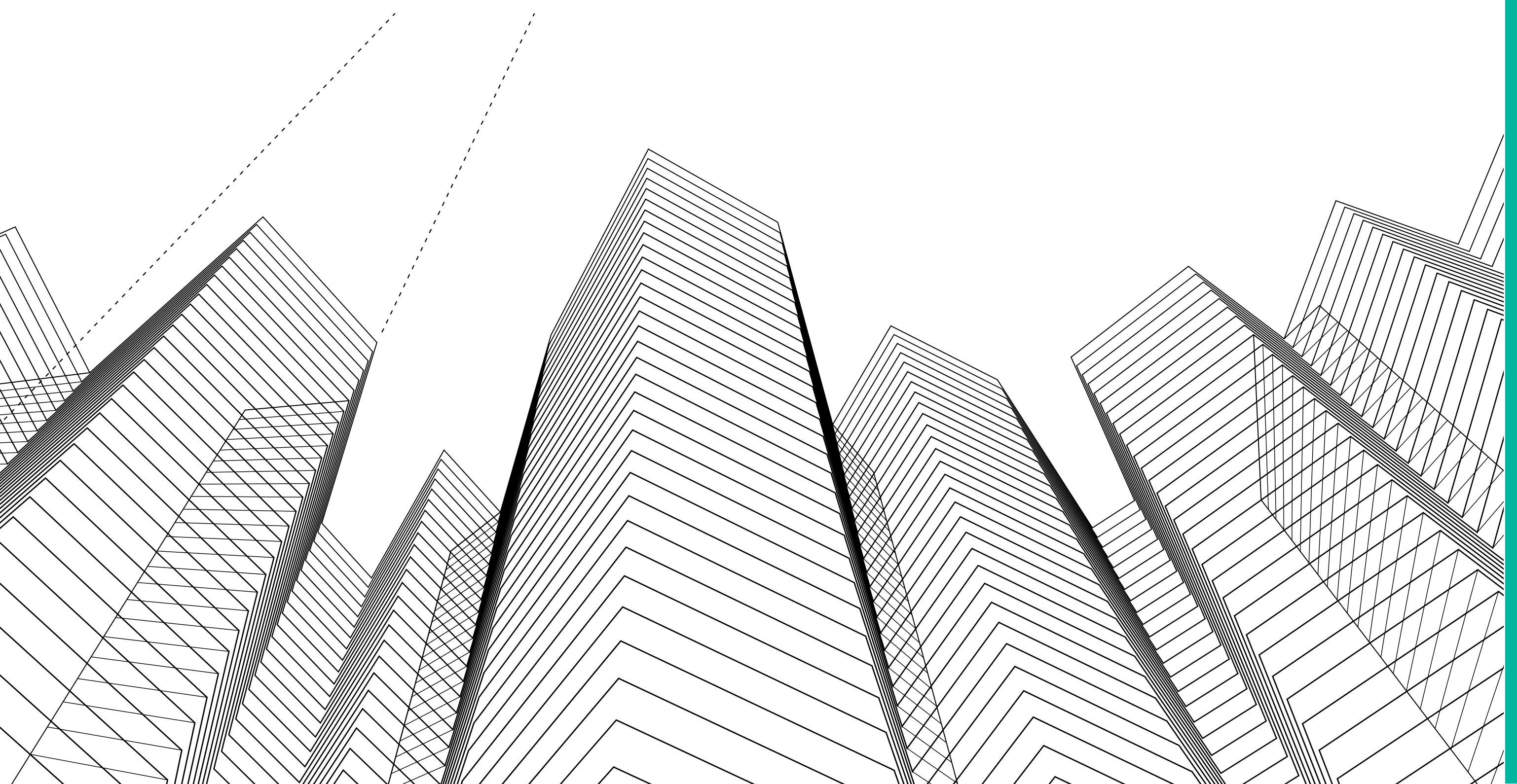

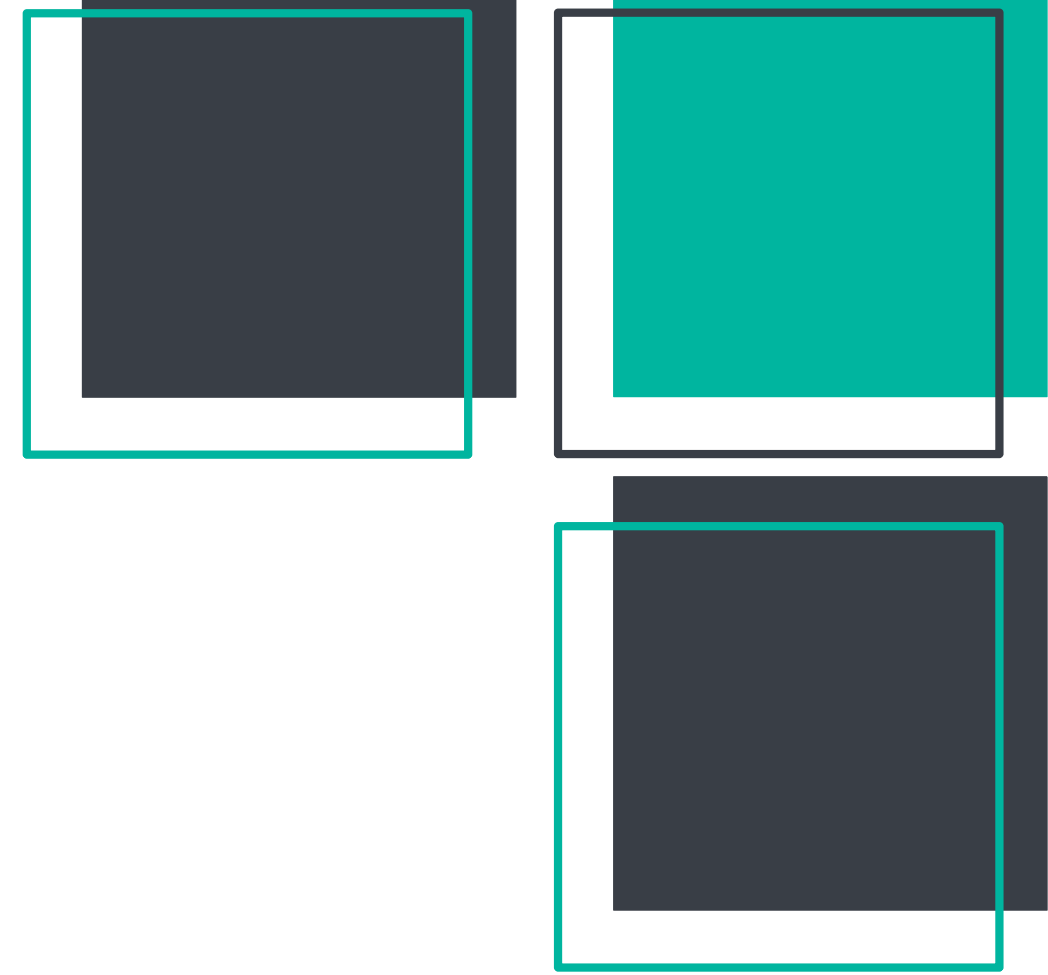
About Us

Throughout the years, we have adapted, expanded, and paved the path for our diverse range of legal experience and clientele.

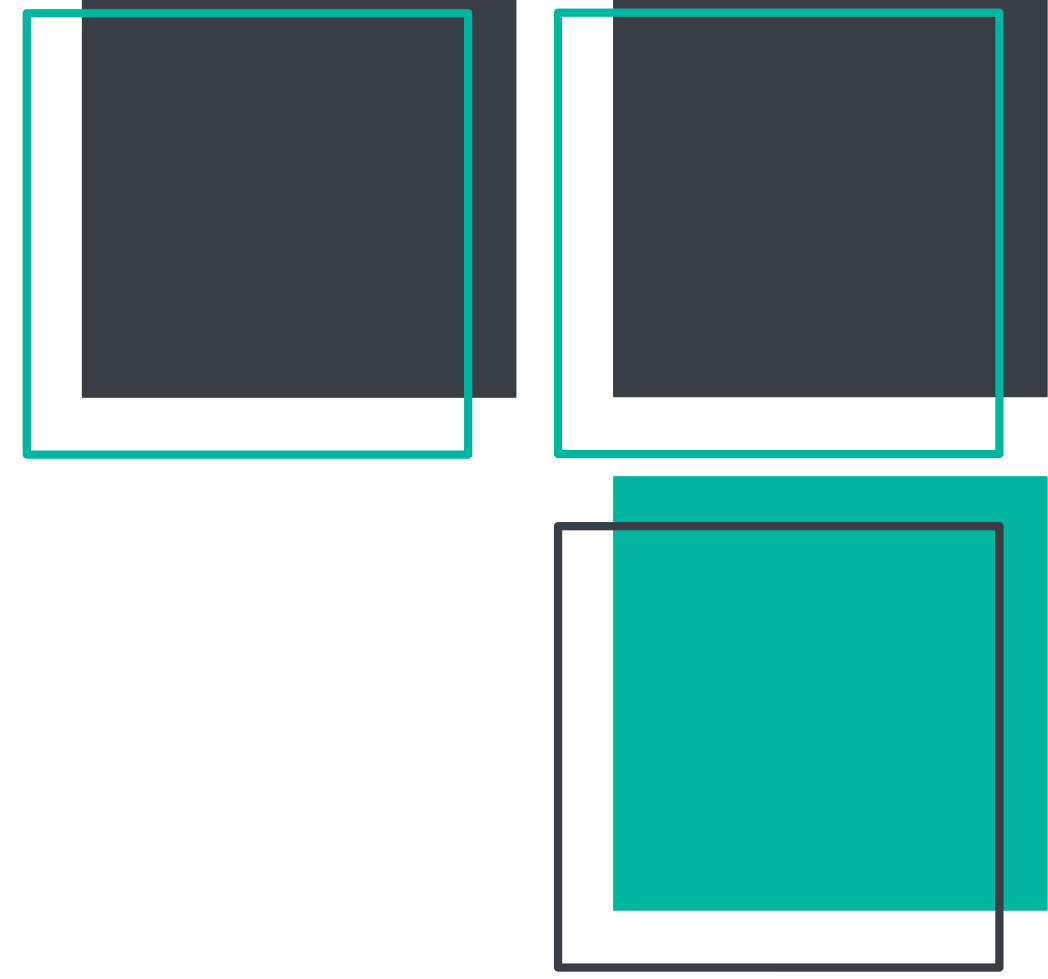
